Richard Narroway Opens Stulberg Season

With WMU Symphony Orchestra

Cellist Richard Narroway joins the Western Michigan University Symphony Orchestra in concert on **Sunday, October 9**, for a performance featuring the works of Russian and Finnish composers. The concert, at **3 pm in Miller Auditorium** at Western Michigan University, is free and open to the public.

Narroway performs Tchaikovsky's Variations on a Rococo Theme, Op.33 The concert also features the WMU Symphony Orchestra who play Sibelius' Karelia Overture and music from Tchaikovsky's Nutcracker Ballet. The symphony is directed by Professor Bruce Uchimura.

A rising star as a cellist, Richard Narroway, last performed in Kalamazoo in May 2015 in a solo concert at First Congregational Church. He played three of the Bach Cello Suites along with three contemporary Australian pieces. In 2010 he was awarded both the Bach award and the gold medal at the annual Stulberg International String Competition.

Narroway is deeply committed to bringing classical music to a wider audience. He has collaborated with the Mark Morris Dance Company and Dance for Parkinson to produce a recording of the Bourrees from Bach's third cello suite for dance classes around the world. Last year he toured

Australia extensively, presenting and performing Bach suites and contemporary Australian composers in an effort to educate students and the public. Born in Australia, Narroway

graduated from Northwestern
University and the Juilliard School and is now studying for a Doctoral degree at the University of Michigan under the tutelage of Richard Aaron.

Austin has served as concertmaster for the American Youth Symphony and the Colburn Orchestra. He is an alumnus of Yellow Barn, the Aspen Music Festival and Music Academy of the West.

Baltimore Chamber Orchestra Partnership Expands Stulberg Performance Opportunities

Performance partners have been critical to Stulberg's success. Longstanding partnerships with the Kalamazoo Junior Symphony, WMU Symphony, Kalamazoo Symphony and Grand Rapids Symphony have allowed Stulberg medalists a very special opportunity to perform concerts with full ensembles. After the 2013 Stulberg Competition, the Baltimore Chamber Orchestra's Music Director, Markand Thakar expressed interest in a similar partnership. This was an opportunity for audiences in a whole new geographic area to hear the talents of the Stulberg Gold Medalists. In November 2014, Youjin Lee, violin, began the tradition. It was followed by cellist Zlatomir Fung in May 2016 with a performance that Baltimore Sun reviewer Tim Smith described as "...a sensitive collaboration." Smith further described the 2014 gold medalists for "...rich, warm tone, impeccable intonation and thoughtful phrasing..." Violinist Yaegy Park will continue the tradition in May 2017.
