Youjin Lee, Stulberg 2013 Gold Medalist, will solo with the Baltimore Chamber Orchestra on November 2, 2014. The BCO's concertmaster, Madeline Adkins, is a Stulberg Gold Medalist from 1997. The seeds for this collaboration were sown during the 2013 Competition, when judge Victoria Chiang connected her husband. **BCO Music Director** Markand Thakar, with the Stulberg. The orchestra occupies an essential niche in the arts scene of Greater Baltimore, and the Stulberg is proud to be a partner for the 2014-15 season.

Local audiences did have a chance to reacquaint themselves with Youjin's artistry when she was featured on NPR's "From The Top", broadcast by local affiliate WMUK 102.1 FM in late December and early January. And in addition to her Stulberg win, Youjin also took first place in the Klein Competition in June of 2013, leading to performances with several California orchestras this year.

Mr. Weilerstein began his career earning top honors at the Juilliard School. He spent twenty years as the first violinist for the Cleveland Quartet, with whom he toured the world. Recordings with them have earned seven Grammy nominations. Over the years, his students have been prizewinners in major competitions and can be heard in many of today's leading orchestras and chamber ensembles.



John Sant'Ambrogio, Cello St. Louis Symphony Orchestra (retired)

Mr. Sant'Ambrogio has enjoyed an illustrious career as a cellist in top orchestras, chamber music ensembles and as a pedagogue for over five decades. He has served on the faculties of Washington University, the St. Louis Conservatory and Boston University and has enjoyed a successful recording career. In 2005, he retired and travels the country with his trio which includes his daughters.



A prizewinner of the Naumburg, Tertis, Washington and Hudson Valley Competitions, Dreyfus has toured worldwide with the Orpheus Chamber Orchestra, Musicians From Marlboro and the New York Philharmonic. She is a successful recording artist and a graduate of the Curtis Institute. Dreyfus was born into a family of musicians and studied viola with Leonard Mogill, Michael Tree and Karen Tuttle.
